Specifications of Bomb Calorimeter

1. System should be PC controlled micro-processor based Isoperibol bomb Calorimeter for high precision and rapid gross calorific value of coal/coke/lignite/oil etc in accordance with international standard test method (ASTM/BIS/ISO) for gross calorific value of coal and coke.
2. Sample Weight- 0.5-1.5 g
3. Range of GCV – up to 8000 or more cal/g
4. Precision - $\leq 0.1\%$ RSD or better
5. Temperature resolution: 0.0001°C
6. Time of Analysis – 7-8 minutes
7. Crucible – Only base metal alloy make has to be supplied. The number of crucibles supplied must be sufficient to analyse >2000 samples or 5 numbers whichever is greater.
8. Combustion vessel/bomb – The calorimetric bomb should be highly resistant to corrosion and certificate for safety of bomb under high pressure as per ASTM E144 should be provided. One extra Bomb/head assembly must be supplied with the instrument. Bombs/heads should be OEM make.
9. Bomb washing after analysis should be fully automatic, no manual operation
10. Correction facilities – User selected option for the correction for acid or % Nitrogen, fuse wire, sulphur, moisture, spiking, ash and hydrogen.
11. Operation – System must be operated through compatible PC with appropriate software for real time temperature, method of storage and graphic display. Instrument should have the facility to interface with the balance, computer and printer.
12. Water Handling – System should have integral, close loop water handling system, which has automatic measuring, filling and drainage of water. The water handling system must be Original Equipment Manufacturer (OEM) made.
13. The system should be capable for directly analysis of powdered coal/Coke etc

Organizations/ Govt. funded academic institutes along with a list of existing users.
22. Manual – Operation and service manual should be provided with the instrument.
23. Installation & training – Installation, training and demonstration on samples for a minimum period of five days should be organised at free of cost.
