Specifications

ROM Sieve Shaker

Purpose: Particle size analysis of bigger / lump particle run of mine material. (ROM)

Sample material: Geological ores, rocks, Bauxite, Laterite, Khondalite, Iron ores, Quartz, Limestone, Dolomite, Coal, Coke, shale, etc.

Operation Mode: Batch operation

Capacity: approximate 15-20 kg sample in a batch

- The test sieve shaker should consist of electromagnetic drive mechanism.
- The unit should have capacity with 13 sieves (400x65mm) installed in one batch. Particles size ranges from 125 mm to 20-micron size should be sieved by using test sieve shaker.
- Sieve diameter: 200 mm- 450 mm and Sieve size: (400 x 65 mm), Timer: 0- 99 minutes.
- The frame should be made of cast aluminium housing.
- Operation of the sieving system should be controlled through a timer and multiple batches of the sample sieved to obtain uniform sieving efficiency. Electromagnetically driven 3D laboratory sieving machine movement saves time and manual re-sieving and comparable sieving results due to a self-adjusting amplitude
- Power: 220 V, 50 -60 Hz, 3 phases with neutral and earth
- The sieve should be ISO certified and ASTM.
- Supplier should provide submit soft copy of brochure, catalogue. operation and maintenance manual with bidding documents. This is mandatory for the technical evaluation.
- Successful bidder should provide installation, commission and training.
- All pre-installation requirements such as space size, required power rating for the equipment, etc. to be provided.
