1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.

Specifications Acid Purification (Distillation)

System for getting High Purity acids

1. We propose to procure acid distillation system suitable for different mineral acids (such as HNO₃, HCl, HClO₄) to produce high Purity acids suitable for ICP-MS sample preparation for trace level analysis. Separate module should be offered for distillation of HF. System should be based on sub-boiling distillation principal to ensure production of very high quality of acid.
2. It should be Dual Distillation systems completely made of high purity quartz to ensure maximum purification quality.
3. Two heating elements for each purification system, for a total of four elements. Top-down heating, located above the acid level.
4. Water cooling provision (chiller) should be there to assure high re-condensation and the maximum purification rate and yield.
